

Sunfish Fleet #133 Application for Guest Racing Privileges

Guest racers must complete and sign the attached application form. The form also requires the signature of a SYC member who has agreed to serve at the guest racers sponsor. The application will be subject to review by the fleet committee charged with reviewing all guest racers request for racing privileges. Upon acceptance to participate in fleet racing guest racers will be charged a \$120.00 fee for the privilege to participate in fleet #133 race activities per season.

Applicants under the age of 30 are subject to the requirements outlined in the official membership policies of the Spofford Yacht Club.

Guest Racer Privileges:

- The opportunity to compete in the SYC Fleet #133 summer race series and to qualify for all SYC sailing awards.
- * The opportunity to participate in after race events including cookouts and race sailing clinics. Guest racers are expected to host a cookout at least once during the race season.
- Access to the clubhouse and related facilities during race days.

Limitations: The Racing Guest privileges are limited to the individual racer. Privileges are not extended to the racing guest members family, houseguests or friends. The guest racer may not introduce other guests to the club or its facilities with the exception of family members attending the post-race award ceremonies. A family member may be invited as a guest of the sponsoring club member or another member of the club in keeping with general club policy. Guest racing privileges are granted solely on a seasonal basis.
